Bio

Since joining the firm David has been involved in representing schools, municipalities, Tribal Nations, and private clients on a variety of issues involving municipal law, land use, environmental law, and land conservation, including zoning matters, interpretation and enforcement of ordinances and litigation of land use complaints, zoning appeals, and real estate law disputes. David has helped conservation organizations qualify for carbon credits on forests that they own and manage in Maine. He has represented conservation organizations and private individuals in establishing conservation easements over working landscapes including farmland and forestland. He has represented clients in administrative proceedings before the land use planning commission, the department of marine resources, and the U.S. Environmental Protection Agency. He was part of the trial team in complex litigation in which a municipality successfully established a public easement for general recreation on a beach in which private landowners had asserted the right to exclude the public after centuries of public use. He successfully represented another municipality against a challenge to changes in health insurance benefits for retirees. He has worked on various matters arising under the Clean Water Act. He has represented school districts before state courts regarding issues arising from bathroom provisions for transgender
