## Bio

## **Representative Clients & Matters**

*Town of North Hampton v. Jones* – Successfully litigated a 9-day trial in which the defendant was found liable for numerous zoning violations. The case involved extensive discovery, including over 10 depositions, as well as hundreds of exhibits.

*CBDA Development v. Town of Thornton* – Successfully defended the Town of Thornton Planning Board before the NH Supreme Court and, in doing so, established the first extension of the Fisher v Dover legal doctrine (which provides that Zoning Boards of Adjustment are not required to review matters that were previously denied) to apply to Planning Board decisions.

*Daniels v. Town of Londonderry* – Successfully defended the Town of Londonderry Zoning Board of Adjustment before the NH Supreme

Court and, in doing so, established new precedent for how to integrate federal regulations into the analysis of variance applications for telecommunications facilities.
