Ryan pursued his Juris Doctor at the University of Colorado Law School, where he received an American Indian Law Certificate, and served as Lead Production Editor for the Colorado Natural Resources, Energy, & Environmental Law Review. During law school he externed with The Wilderness Society and National Audubon Society, and worked on a variety of projects including review of federal Resource Management Plans, Environmental Assessment and Environmental Impact Statements, and proposed rules affecting energy and natural resource development on federal public lands. Ryan received a Bachelor of Arts degree from Colby College and is admitted to practice in the State of Maine, Penobscot Nation Tribal Court, and Passamaquoddy Tribal Court. He is
