## **Representative Clients & Matters**

- Represented five NH municipalities (along with other similarly interested parties) and successfully sought denial from the State of NH Site Evaluation Committee for the Northern Pass transmission line. Consideration of the Northern Pass project took more than a year, involving hundreds of parties, thousands of documents, and an adjudicative hearing that required 70 days to complete over a calendar year.
- Received a favorable outcome at Board of Tax and Land Appeals in a tax abatement proceeding involving large natural gas utility – a 10-day trial that involved very technical testimony of expert witnesses on both sides.
- Helped a client with years long zoning enforcement case to obtain court order to cease violations, award of all attorney fees, and significant sum of civil penalties.
